DECISION

JRS BUSINESS LLC D/B/A MIDDLETON BEER, WINE, TOBACCO & MORE 251 SOUTH MAIN STREET 1A MIDDLETON, MA 01949 LICENSE#: 90155-PK-0704 VIOLATION DATE: 4/01/2025 HEARD: 6/24/2025

JRS Business LLC d/b/a Middleton Beer, Wine, Tobacco & More ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, June 24, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: Ch. 138 § 34 – Possession of an alcoholic beverage by a person under twenty-one (21) years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Anderson & Bolcome's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- Investigators Anderson & Bolcome's Minimum Purchase Age Compliance Check Field Report, 4/1/2025;
- 2. ABCC Licensing Authority Certification, Transfer of License Approved, 12/23/2021;
- 3. Licensee Stipulation of Facts.

FINDINGS OF FACT

- On Friday, April 1, 2025, at approximately 5:54pm, Investigators Anderson and Bolcome ("Investigators") conducted a compliance check at JRS Business LLC d/b/a Middleton Beer, Wine, Tobacco & More.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 4-pack of Kona Big Wave (16 oz.) for nine dollars (\$9.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2021 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
