**MIDDLETON SHREEJI, INC. D/B/A RICHDALÉ

Middleton Shreeji, Inc. d/b/a Richdale (“Licensee”) holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (“Commission” or “ABCC”) held a hearing on Tuesday, September 9, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Bolcome & Anderson’s Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Bolcome & Anderson’s Minimum Purchase Age Compliance Check Field Report, 4/1/2025;
2. ABCC Licensing Authority Certification, New License Approved, 7/28/2023;
3. Licensee’s Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

1. On Friday, April 1, 2025, at approximately 6:06 p.m., Investigators Bolcome & Anderson (“Investigators”) conducted a compliance check at Middleton Shreeji, Inc. d/b/a Richdale.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24oz Corona beer for four dollars and ninety-nine cents (\$4.99). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2023.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
