## HOUSEHOLD GOODS AND FURNITURE

### RATES AND CHARGES

#### Per Hour

1<sup>st</sup> to 15<sup>th</sup> of each month

Vehicle (16 ft.), driver and helper-----	\$75.00
Vehicle (24 ft.), driver and 2 helpers-----	\$105.00

15<sup>th</sup> to end of each month

Vehicle (16 ft.), driver and helper-----	\$85.00
Vehicle (24 ft.), driver and 2 helpers-----	\$120.00

### Computing Time

Unless otherwise provided herein, time charges will be computed at the hourly rate applicable from the time vehicle, helper or supervisors leave the terminal until the arrival back at the terminal, less time spent for meals, vehicle breakdown or repair, subject to the following:

Charges based in time shall be computed by multiplying the hourly rate by the time involved. Unless otherwise provided, fractions of an hour will be disposed of as follows: Where the time involved is less than 15 minutes, one quarter hour. When in excess of 15 minutes, but not more than thirty (30) minutes, charge on-half hour. When in excess of 15 minutes, but not more than forty-five (45) minutes, charge for three-quarters of an hour. When in excess of 45 minutes charge for one hour.

**DEFINITION** - The term "Household Goods and Furniture" as used in this tariff means: The transportation of furniture and household goods in whole or in part incident to a move by a householder to or from a dwelling and a storage warehouse; or from one dwelling to another.

**ESTIMATES/QUOTATIONS** - Carrier cannot quote a firm price on a move from a residence or establishment to another if a public way has to be used by a vehicle. He may give a written estimate, but in doing so be qualified to estimate within twenty-five (25%) of the actual charges. The final charges to be assessed shall be in accordance with actual tariff rates.
