

Reporting Options

Restricted Report: Reporting option that allows sexual assault victims to confidentially disclose the assault to specified individuals (e.g., SARC, SAPR VA, or healthcare personnel) and receive medical treatment, including emergency care, counseling, and assignment of a SARC and SAPR VA, without triggering an official investigation unless the victim consents.

Unrestricted Report: A process that an individual uses to disclose, without requesting confidentiality or restricted reporting, that he or she is the victim of a sexual assault. The victim's report is reported to law enforcement and may be used to initiate the official investigation process

* In investigations initiated upon third-party reports or by command, victims may choose to decline to participate by submitting Sec 540K Declination Letter.

Did You Know?

- Expedited Transfers are available to military members (and depending on the branch of service, can be available to their military dependents as well)
- Retaliation and Reprisal can result in punishment
- If the alleged subject is the commander or in the victim's chain, the victim can go outside the chain of command to report the offense
- Military Protective Order is an option for victims who file an unrestricted report
- Allegations of sexual harassment can be filed with a Military Equal Opportunity representative

Victim's Bill of Rights

DoD Victims' Bill of Rights resembles the Federal Crime Victims' Bill of Rights. DoD law enforcement and legal personnel directly engaged in the detection, investigation, or prosecution of crimes are responsible for ensuring that victims of military-related crime are accorded the following rights:

- To be treated with fairness
- To be treated with respect for your dignity and privacy
- To be reasonably protected from the accused offender
- To be notified of court proceedings
- To be present at all public court proceedings related to the offense unless otherwise determined by the court
- To confer with the attorney for the government in the case
- To receive available restitution
- To be provided with information about the conviction, sentencing, imprisonment, and release of the offender

Educate, advocate, and collaborate to respond to and stop sexual assault and its harmful effects on the military force



Available Services & Point of References

Sexual Assault Prevention and Response (SAPR) Offices provides 24/7 victim care and assistance that is gender- responsive, culturally- competent, and recovery oriented to sexual harassment and assault victims and survivors

Confidential Communication—Process to report or disclose sexual assault in a confidential manner with SAPR Personnel

Sexual Assault Response Coordinator (SARC)—Single point of contact to coordinate sexual assault victim care

SAPR Victim Advocate (SAPR VA)—Provides non-clinical essential support and care and resource options to victims

Victim's Counsel (VC)—Legal representation for victims of sexual assault and domestic violence throughout the investigations & to assert victim's rights in the military justice process

Medical Support—Comprehensive medical evaluation, medical forensic examination and treatment of injuries and reproductive risk exposures and infections

Mental Health Support—Providers trained to support survivors of trauma

MCIO- Military Criminal Investigative Org

Catch A Serial Offender PGR.- This gives people making a sexual assault report, where the name of the suspect is not known by law enforcement, an opportunity to anonymously submit suspect info to help identify serial offenders.

50 Year Document Retention— SAPR office maintains reporting document (DD 2910) for 50 years allows for use if/when military Veteran is ready to file benefits application with Veteran Affairs

Expedited Transfer—Option for PCS (perm change of station) or PCA (perm change of assignment) for unrestricted reports

Hanscom Air Force Base
