DECISION

RED ROBIN INTERNATIONAL INC. D/B/A RED ROBIN 70 WORCESTER PROVIDENCE TURNPIKE MILLBURY, MA 01527 LICENSE # 07453-RS-0712

HEARD: 5/28/2024

Red Robin International Inc. d/b/a Red Robin ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, May 28, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Binienda & Velez's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Binienda & Velez's Minimum Purchase Age Compliance Check Field Report, 5/1/2024;
- 2. ABCC Licensing Authority Certification, Transfer of License;
- 3. Licensee's Stipulation of Facts:

FINDINGS OF FACT

- 1. On Monday, May 1, 2024, at approximately 2:49 p.m., Special Investigators Binienda and Velez ("Investigators") conducted a compliance check at Red Robin International Inc. d/b/a Red Robin.
- 2. An underage operative, working under the supervision of Investigators, was served a Bud Light draft beer but did not pay. The underage operative was not asked for identification.
- 3. The Licensee holds a license under M.G.L. c. 138, § 12 and has no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
