DECISION

Riverside, Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, July 25, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Velez & Binienda's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Velez & Binienda's Minimum Purchase Age Compliance Check Field Report, 4/19/2023;
- 2. ABCC Form 43, New License Approval, 4/10/2001;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, April 19, 2023, at approximately 5:20 p.m., Investigators Binienda and Velez ("Investigators") conducted a compliance check at Riverside, Inc.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 16.9-ounce container of Beatbox Blue Razzberry Party Punch malt beverage, for four dollars and ninety-nine cents (\$4.99). The underage operative was not asked for identification.
- 3. Mr. Fadi El-Massih, Licensee, appeared at the Commission hearing. Mr. El-Massih testified he changed his software system which now requires employees to scan an identification prior to making a sale.

4. The Licensee has held a license under M.G.L. c. 138, § 15 since 2001 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
