DECISION

T & P LIQUOR LLC D/B/A MILLBURY LIQUORS 123 MAIN STREET MILLBURY, MA 01527 LICENSE # 00015-PK-0712

HEARD: 5/28/2024

T & P Liquor LLC d/b/a Millbury Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, May 28, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Special Investigators Binienda & Velez's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Special Investigators Binienda & Velez's Minimum Purchase Age Compliance Check Field Report;
- 2. ABCC Form 43 Transfer of License Approved, 6/10/2016;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- On Wednesday, May 1, 2024, at approximately 5:12 p.m., Special Investigators Binienda and Velez ("Investigators") conducted a compliance check at T & P Liquor LLC d/b/a Millbury Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one can of Michelob Ultra beer for three dollars and ninety-nine cents (\$3.99). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2016 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
