FINAL DECISION

I am the Final Decision -Maker in this appeal by special designation.

On May 17, 2022 the parties filed a Joint Stipulation of Dismissal requesting dismissal of this appeal. The Joint Stipulation of Dismissal constitutes a waiver by the petitioners to any further administrative review before the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”) as well as appeal to court of the Noise Pollution Abatement Order (“NPA Order”) issued by the Town of Concord Board of Health on October 13, 2021. Accordingly, the Department issues this Final Decision incorporating the Joint Stipulation of Dismissal, and dismisses this appeal.
