CALL TO ORDER: The meeting was called to order by Mr. MacDonald at 1:30 p.m.

Item #1 **MOTION- VOTE**

Acceptance and Approval of May 4, 2022 Minutes

The motion was made by Mr. Yontar and seconded by Commissioner Suuberg and voted unanimously in favor of acceptance and approval of the minutes of the meeting of the Board held on May 4, 2022.

Item #2 **REPORT OF THE EXECUTIVE COMMITTEE**

Ms. Perez said that next week, the Trust will have a booth in the exhibitor hall at the Annual Massachusetts Collectors & Treasurer's Associate Conference. Mr. Derouen will be giving a presentation on the Trust's financing programs.

The final 2022 Intended Use Plans (IUPs) have been published.

The Trust is working on applying for its annual EPA and Bipartisan Infrastructure Law (BIL) grants. We are looking to use funds from these grants for new initiatives such as a new lead service line planning program which is up for Board approval at this meeting. Working groups will meet to discuss other grant fund uses.

The next Board meeting will be on June 29th rather than July 6th.

Item #3 MOTION- VOTE

The motion was made by Commissioner Suuberg and seconded by Mr. Yontar.

Ms. Perez said that another response was received for the ongoing prequalification of consulting engineering firms for the development of asset management plants request for responses. The responding firm was GZA GeoEnvironmental Inc. The procurement management team met and evaluated the response according to the memo that has been presented to the Board.

The motion was voted unanimously in favor of acceptance and approval of the following:

Prequalification of Consulting Engineering Firm for the Development of Asset Management Plans for Eligible Borrowers

That the recommendation of the procurement management team, established pursuant to the Trust's request for responses, dated June 2, 2021, distributed to the Board, to prequalify a firm to provide consulting engineering services to "eligible entities" that are Massachusetts cities, towns, and utility districts for the development of asset management plans, is hereby approved.

That the Board hereby delegates to the Executive Director, and/or other authorized officers of the Trust, all necessary power and authority to take any such further action as necessary to finalize the prequalification of the selected firm.

Item #4 **MOTION- VOTE**

The motion was made by Mr. Yontar and seconded by Commissioner Suuberg.

Mr. Keenan said that this program has been in development since BIL was signed. The latest EPA guidelines gave us what we needed to finalize this program.

The goal of the program is to be free to the communities but due to EPA regulations, grants are more administratively burdensome than running the program as 100% loan forgiveness.

We are hoping to see communities complete the planning process through our new program and then apply for loans for capital projects to come into compliance with the Lead and Copper Rule Revisions.

The motion was voted unanimously in favor of acceptance and approval of the following:

Lead Service Line (LSL) Planning Program

- 1. The Trust hereby approves the establishment of a program (the "LSL Planning Program") to provide financial assistance in the form of loans subject to 100% principal forgiveness, to assist eligible borrowers to inventory and plan for the replacement of lead service lines within and connecting to such borrowers' drinking water systems. LSL Planning Program Loans are authorized in an aggregate amount of up to \$20 million to be funded from, and subject to the terms and conditions of, federal Supplemental Lead Service Line Capitalization Grants made pursuant to the Bipartisan Infrastructure Law and available federal grant moneys under the Water Infrastructure Transfer Act.
- 2. The Trust authorizes and directs the Executive Director, and such other officers of the Trust as the Executive Director may delegate, to develop such additional LSL Planning Program description and documentation (including without limitation financing agreements), to cooperate with the Department of Environmental Protection to solicit proposals for loans eligible for the LSL Planning Program, to deliver such certifications, agreements and notices and to perform all such further steps and actions as necessary or convenient to effect implementation of the LSL Planning Program.

Item #5 **MOTION- VOTE**

The motion was made by Commissioner Suuberg and seconded by Mr. Yontar.

Mr. Keenan said that the MassDEP Drinking Water Program identified small public water suppliers (PWSs) that may not have the administrative capabilities to access the 100% loan forgiveness program through the Trust. The \$1.3 million from the approval of this motion will help provide technical assistance to those small PWSs to complete the same lead identification and planning work as the loan forgiveness program.

Mr. MacDonald asked if MassDEP will be conducting outreach.

Ms. Pinaud said that the MassDEP Drinking Water Program works with small PWSs regularly. They will do a multi-channel outreach to the small PWSs. The 2022 Drinking Water Intended Use Plan (IUP) will be amended to inform the public of this opportunity. E-mail announcements will go out to all communities when the 2023 IUP SRF project solicitation opens in July.

The motion was voted unanimously in favor of acceptance and approval of the following:

Fund LSL Small System Technical Assistance

1. The Trust hereby approves the transfer to the Department of Environmental Protection (DEP) of up to \$1.3 million of Small System Technical Assistance set-asides under federal Supplemental Lead Service Line Capitalization Grants made pursuant to the Bipartisan Infrastructure Law, for use by DEP, subject to the terms and conditions of such federal grants, in providing direct technical assistance to small drinking water systems to inventory and plan for the replacement of lead service lines within and connecting to such small drinking water systems.

The motion was made by Mr. Yontar and seconded by Commissioner Suuberg and voted unanimously in favor of acceptance and approval of the following:

Item #12 **MOTION- VOTE**

The motion was made by Mr. Yontar and seconded by Commissioner Suuberg.

Mr. MacDonald asked if this round is the first to offer grants beyond public schools.

Mr. Maple confirmed that this and the previous vote included projects for private facilities. These projects are funded from a grant awarded by the US EPA in 2021 to expand SWIG eligibility. With this motion, the Trust will have awarded four grants to private facilities.

The motion was voted unanimously in favor of acceptance and approval of the following:

School Water Improvement Grant (SWIG) Program

On January 8, 2020, the Board approved the establishment of a School Water Improvement Grant (SWIG) program to provide assistance in the form of grants (including, without limitation, an additional subsidy equivalent to a loan at an interest rate of zero percent and principal forgiveness, as provided in Section 6(c) of the Enabling Act) to eligible borrowers for the procurement and installation of point-of-use filtered water bottle-filling stations in eligible educational facilities where there are known lead exceedances (as determined by the Department of Environmental Protection).

The following vote approves the awarding of grants to recipients and in the amounts as specified in such vote, subject to the terms of the applicable grant agreement.
