CALL TO ORDER: The meeting was called to order at 1:30 by Treasurer Goldberg.

Item #1 **MOTION – VOTE**

The motion was made by Ms. Madden, seconded by Commissioner Suuberg, and voted unanimously in favor of the acceptance and approval of the minutes of the meeting held on May 4, 2016.

Item #2 REPORT OF THE EXECUTIVE COMMITTEE

Ms. Perez asked Commissioner Suuberg to update the Board on the initiative to test public school drinking water for lead contamination.

Commissioner Suuberg reported that the initiative is offering additional technical assistance and sampling of public school water pursuant to the Federal Lead Contamination Control Act. Requests for information were sent to school districts and the response to date has exceeded 1083. The Commissioner expects to receive close to 1780 responses in total. DEP is prioritizing responses and focusing on the worse situations, such as buildings with old plumbing. The initiative has been able to develop good partnerships with the schools and has been well received by the communities.

Mr. Keenan distributed a power point presentation to the Board on EPA's clean water grant allotment report to Congress under the Water Resources Reform and Development Act. That Act directed EPA to review the grant allotment formula and determine whether it adequately addressed the water quality needs of eligible recipients. The Board discussed the three options EPA presented to Congress and each of their possible effects on Massachusetts' Federal clean water grant. Mr. Keenan stated that, depending on the option used, Massachusetts' grant could be reduced from the current 2016 amount by \$13.2 million under the least costly option to as much as \$20 million under the most costly option. Mr. Keenan noted that Congress does not have to act on the report from EPA. Nonetheless, Treasurer Goldberg recommended that the state congressional delegation be informed of the impact on Massachusetts.
