Ms. Griswold reviewed various topics to be addressed including (1) how retail pharmacies can support patient use of the MedList; (2) the process of reconciling medications in office practices, health centers, ambulatory clinics, and hospitals; and (3) available formats (medication patient profile (unduplicated list); hospital emergency rooms; ambulatory clinics, and patient's personal medication lists). Board members provided comments on proposed format to enhance usefulness of list to improve patient medication safety.
