Corrective actions implemented described as: all new prescription data entry must be verified by pharmacist and technician; lithium citrate and chloral hydrate have been separated so that they are no longer in close proximity; and private password for pharmacists. <u>Pharmacist:</u> Motion/Ryle to issue Advisory Letter, complete two hours of CEs in Medication Error Prevention, and file USP Medication Error

Report Form. Second/Pasedis. Unanimous in favor.
