Director Bonner reviewed DPH Drug Control Program (DCP) regulations revisions (105 CMR 700.012) regarding the **Prescription Monitoring Program**, which were adopted by Public Health Council on August 11, 2010. The regulatory amendments are expected to be filed with the Secretary of State on August 20, 2010, with regulation effective date of September 3, 2010 and reporting requirement implementation date of January 1, 2011.

Board Counsel Susan Manning reviewed recent PMP legislation "An Act Adding Safeguards to the Prescription Monitoring Program and Furthering Substance Abuse Education and Prevention" (Chapter 283 of the Acts of 2010), adding new Section 24A to MGL c. 94C (signed by Governor Patrick on August 9, 2010 with PMP sections (Section 3) effective January 1, 2010). Board also reviewed proposed revisions to Board regulation 247 CMR 5.04 Reporting Requirements to the Prescription Monitoring Program (PMP), which conform Board PMP regulations with the DCP revisions to 105 CMR 700.012 (reviewed by Drs. Bonner and Carrow) and recent amendments to MGL c. 94C regarding PMP (new Section 24A).

Board members discussed various issues and concerns relating to work setting internship hours, preceptor responsibilities, and internship placement opportunities. Dean Pisano stated his intention to survey students in the early fall to determine the perspectives on the availability of intern positions outside of college rotations.
