Assistant Chair Fagan called the meeting to order at 7:02am with Roll Call: Christine Fagan, present: Greg Dorrance, present: Dr. Henry Vaillancourt, present: Joseph Carvalho, present.

MINUTES:

MOTION made by Henry Vaillancourt to accept the minutes of the May 27, 2025 meeting. Seconded: Joseph Carvalho. No further discussion, motion passes unanimously via roll call, 4-0.

VOTE FOR NEW CHAIR:

Commissioner Henry Vaillancourt started the conversation with nominating Commissioner Fagan and discussion ensued.

MOTION made by Henry Vaillancourt to nominate Christine Fagan for Chair of BCMCP's Commission. Seconded: Greg Dorrance. No further discussion, motion passes unanimously via roll call, 4-0.

SEARCH FOR NEW COMMISSIONER:

Superintendent Matton asked for any suggestions on contacts for the available commission position. Discussion ensued and Superintendent Matton reached out to a retired public health nurse and board of health agents in the county.

PROPERTY LEASE UPDATE:

Superintendent Matton provided an update from DCAMM on the status of lease renewal. Since February DCAMM and BCMCP have been working on a "uniqueness" determination to renew the lease following legal review. DCAMM legal did not approve the renewal so BCMCP will follow the RFP process and post the legal notice shortly.

IT MIGRATION TO STATE SERVICES:

Superintendent Matton updated the Commission on MDAR/SRMCB's decision to require Project's to migrate their IT services to state services. Since BCMCP has older server hardware and upcoming IT program renewals, we requested to be first in the process. However, there was a ransomware attack at Central Mass Mosquito, it is possible there will be a change in priority for the state. An update will be provided at the next meeting.

FIELD UPDATE:

Entomologist Todd Duval continues to provide his weekly report via email. Superintendent Matton stated residential requests began on June 2 and applications on June 9. There have been approximately 1800 calls received for service.

NEW BUSINESS:


Next SRMCB meeting is scheduled for July 8, 2025 at 1pm.
