Move: That the Pesticide Board Subcommittee has determined that the use of the following product

1. A23544 ST, EPA Reg. No. 100-1720-1381, containing thiamethoxam and sedaxane

May cause an unreasonable risk to man or the environment, when taking into account the economic, social, and environmental costs and benefits of their use. This determination is based upon the leaching potential and toxicological concern of this substance as defined in the "Protection of Groundwater Supplies from Non-Point Source Pesticide Contamination" Regulations. Therefore, the Subcommittee hereby modifies the registration classification of agricultural/commercial pesticide products containing *thiamethoxam and sedaxane* from general to restricted use for groundwater concerns.

This use of the Kerb SC product will be available for the upcoming growing season.
