Restricted Use As Defined under the Groundwater Protection Regulations:

- 1. Bastante Herbicide, EPA Reg. No. 2749-604, containing bentazon,
- 2. Bastante Max Herbicide, EPA Reg. No. 2749-613, containing bentazon

May cause an unreasonable risk to man or the environment, when taking into account the economic, social and environmental costs and benefits of their use. This determination is based upon the leaching potential and toxicological concern of this substance as defined in the "Protection of Groundwater Supplies from Non-Point Source Pesticide Contamination" Regulations. Therefore, the Subcommittee hereby modifies the registration classification of agricultural/commercial pesticide products containing *bentazon and atrazine* from general to restricted use for groundwater concerns.

Restricted Use Classification for Certain Neonicotinoids Products:

be registered as restricted use pursuant to the Subcommittee's decision on March 1, 2021, to modify the registration classification of pesticide products containing neonicotinoids that have outdoor non-structural uses or outdoor non-agricultural uses on the label from general use to state-restricted use.

D. SPECIAL LOCAL NEEDS REGISTRTION (SLN-24C)

The Department received a request for renewal of the existing SLN for Dual Magnum herbicide (a.i., *S*-metolachlor), to control certain weeds in various vegetable crops in Massachusetts. The specific local need use of

this herbicide is an important tool in high-value vegetable crops. Use pattern, efficacy, and crop safety varies by state and region and SLNs are used to address the specific situations in states and regions. The existing SLN label expires by the end of the year. The end of the 5-year term for the SLN provides an opportunity for evaluation if the special local need situation still exists and renewal label and continuation of this state registration is needed. This SLN use was first registered in 2007 and was amended and renewed several times.

The meeting packet included SLN initiation and application forms and associated supporting documents, and the SLN label with an update expiration date of December 31, 2027.

Dr. Hillary Sandler from the University of Massachusetts Cranberry Experiment Station explained how the use of Dual Magnum remains a very important tool for vegetable growers. Several weeds are difficult to impossible to control without substantial hand weeding. Hand labor is both expensive and difficult to secure. The shortage of hand labor during COVID highlighted even more the need for and value of this product in high-value specialty crops. Sandler pointed out that it is a particularly effective herbicide that fits well into rotational programs because Dual Magnum offers effective control for these weeds while having a short residual activity that greatly decreases carry-over concerns for subsequent crops.

LaScola-Miner sought clarification regarding which crops is this product is mostly used on in Massachusetts. Sandler indicated that it is used on sugar beets, onions, garlic, small fruits, blackberries, raspberry, blueberries, cucumbers, and 14 other crops. LaScola-Miner also asked about why the registrant for this product did not choose to add these special local need crop uses to the section 3 label. Wijnja indicated that this is sometimes done with SLNs but not in every case. The registrant of Dual Magnum prefers to address the regional and local needs through SLNs and that is an option under pesticide laws and regulations. res.
