Mr. Cohen noted that there was only one piece of the standards that was required. He asked what the rationale was for not having more stringent requirements at this point. Mr. Stanek said that these

standards were viewed as a starting point and the hope was to be able to chart out a path in the coming years and to use the certification standards to move in a productive direction at a manageable pace.

Ms. Blakeney said that she was encouraged by the work the HPC was doing to adhere to its commitment to advance health equity.
