Complainant reports six days of ingestion where started to feel "sick and dizzy". She returned to the pharmacy and spoke to the Manager of Record, Andrew Weisburgh, R.Ph., (License No. 25678) about the incident.

CEs: compliant

Registrant admitted to dispensing Benztropine 1 mg instead of the prescribed Clonazepam 1mg. stating the prescription was read incorrectly by the technician. Registrant stated that as the verifying pharmacist he should have caught the error.

Manager of Record stated that he informed the complainant of the medication error when she returned to the pharmacy and paged her physician to inform him. Manager asked the patient for her phone number and called her at home to ensure that she had arrived home safely. The next day, he informed the Registrant and technician of the incident.

Complainant said that she would like to see pharmacists be a lot more careful with dispensing medications.

The patient allegedly received the incorrect medication between October and January of 2004 for a period of 75 days until a routine physical revealed the medication error.

Registrant admitted to dispensing Tramadol 50mg instead of the prescribed medication Trazodone 50mg. Registrant apologized for the medication error. Registrant stated handwriting was unclear, therefore, should have questioned and verified prescription with physician.

Manager of Record stated staff is required to offer counseling to every patient, however, they do not have written documentation to indicate this patient was offered counseling. Corporate office is notified of medication errors. <u>Pharmacist:</u> Motion/Cayer to take matter under advisement. Second/Pasedis. Unanimous in favor.

Motion/Cayer issue an Advisory Letter with completion of two hours of CEs in Medication Error Prevention and a USP Medication Error Report Form. Second/DeVita. Unanimous in favor.
