Matters of Meetinghouse Pharmacy and Baldwin Ihenacho, R.Ph. – Complaint Docket Nos. 2008 1023 DS 024 and 2008 1023 PH 054

On October. 31, 2008, Board received (fax) affidavit of DEA Special Agent Anthony Roberto detailing internet pharmacy activities of Baldwin I. Ihenacho, R.Ph., owner and MOR of Meetinghouse Pharmacy, Bowdoin St., Dorchester, and wife G. Iheancho, R.N. Pursuant to October 21, 2008 Board vote, after review of the Affidavit, the Board issued a Temporary Orders of Suspension on the same date, to be effective the following day (November 1, 2008). Later on October 31, 2008, a US DOJ DEA magistrate hearing issued an Order to Show Cause and Immediate Suspension of Registration, authorizing the DEA removal of all controlled substances from the Meetinghouse premises. On November 1. Saturday, federal authorities removed all drugs from the Pharmacy and took into B. Ihenacho (pharmacy) and wife (residence) into custody. Board agents then entered pharmacy; delivered the Temporary Orders of Summary Suspension of Store and Owner; conducted inspection; and posted notice of closure by Board. -No embargo was placed since all drugs had been removed. The affidavit remains under seal until released by federal judge for use in Board proceedings. The individuals are represented by counsel. Current status of both individual and store registrations is suspended - the pharmacy is closed.

Bourne Pharmacy (DS-06-074) and Gerald Liberfarb (PH-06-011)

Liberfarb seeks Board approval to take NAPLEX and MPJE. Liberfarb was previously disciplined by the Board (two year suspension). Current status: Suspended. Board to advise that no approval for examination prior to review of hearing officer's proposed Final Decision after hearing.

Louis and Clark Pharmacies - Continuation of Review of Pending Complaints

Board reviewed multiple pending complaints, including information from 10/21/08 investigative conferences and information submitted by registrant in response to complaints. Board staff will revise Consent Agreement in accordance with Board discussion and review with Board.
