# <u>Minutes</u> Board of Boiler Rules Department of Fire Services One State Road, Stow, MA 01775 Meeting of November 3, 2022

<u>Meeting called to order by the Chairman, Ed Kawa, at 10:02 A.M.</u> The Chairman opened this meeting of the Board of Boiler Rules, explaining that in accordance with M.G.L. Chapter 146 Section 3, the Board is holding a public hearing to hear petitions to make changes to 522 CMR; also, the Board is conducting a regular meeting. This meeting is being held online via Microsoft Teams, and is being recorded.

- 2) <u>Public Hearing for Petitions to make Changes to 522 CMR</u>: The Chairman asked if there was anyone in attendance who wanted to be heard. With no replies, he explained that the 'hearing' would remain open for the duration of the meeting, and for a minimum of one hour in case anyone joins the meeting who wants to be heard.
- 3) <u>Minutes from previous meetings</u>: The minutes from the previous meeting held on July 7, 2022, were reviewed. *Motion to approve the minutes made by Anthony Lucia, seconded by Leah Francis; motion passed by unanimous roll call vote.*

5) <u>Review of 522 CMR 1.03</u>, <u>Standards Adopted</u>: The Chairman explained that we promulgate 522 CMR approximately every two years, with the primary focus on changes made in the most current editions of those standards listed in 1.03. For the past several years, the Board has stood-up a subcommittee chaired by Board Member Anthony Lucia, with DFS staff assistance, to conduct this review, and make recommendation to the Board as to whether to adopt the current editions, or to adopt Mass. amendments. *Motion to stand up the sub-committee to review the current standards and make recommendation to the Board made by Charlie Perry, seconded by Anthony Lucia; motion passed by unanimous roll call vote.* 

The Chairman added that he will prepare a memo directing the Committee to conduct this review.

- 6) <u>Updates from DFS Staff</u>: The Chairman informed the Board that two new district inspectors have been hired, and have successfully achieved their National Board commissions. Andrew Crear has been assigned to one of our Boston districts, and Greg Folsom has been assigned to a new district in Norfolk County.
- 7) <u>Matters not reasonably anticipated</u>: None.
- 8) <u>Adjournment of Meeting</u>: The next meeting is tentatively set for Thursday, December 1, 2022. Motion to adjourn the regular meeting made by Anthony Lucia, seconded by Leah Francis; motion passed by unanimous roll call vote, regular meeting adjourned at 10:18 AM.
