The purpose of the conference is to discuss a complaint filed with the Board alleging the failure to fill a prescription properly for a patient. The complaint alleged that on or about November 19, 2004, the Registrant (Lane) dispensed Theophylline ER 200mg tablets rather than the prescribed Uniphyl 200mg while employed at Lawrence General Hospital Pharmacy, One General Street, Lawrence, MA. The medication was allegedly administered by hospital nurses to a patient for about ten days prior to incident reconciliation.

Investigator: James C. Emery

CEs: compliance

Present: Registrant, Deanna King, Director of Pharmacy

Registrant admitted to dispensing Theophylline ER tablets 200mg instead of the prescribed medication Uniphyl 200mg. Registrant stated that handwriting on prescription was unclear, instead of calling physician for clarification he assumed prescribed medication was Theophylline. Registrant said there are no excuses, he should have called physician. He has learned a lesson from this incident. In the future, he will call doctor or nurse or call the operator to have doctor paged.

Director of Pharmacy stated that Department of Pharmacy policies and procedures for formulary and non-formulary substitutions have been revised.
