Business Operations Report

- Ms. Kougias provided a summary of the proposed Senate Budget Amendment 614, "Retirement Plus", which would allow some Department of Elementary and Secondary Education (DESE) employees to be reinstated into the Teachers' Retirement Board or Boston Retirement Board while working at DESE. Such employees would retire from the MSRB. It would also allow a window of opportunity for those who did not originally elect the Retirement Plus benefit to do so. Senior staff and Treasury Policy staff met with members of the Teachers' and Boston Retirement Boards and all expressed similar concerns, including the significant costs to implement. A joint letter was submitted to Senate Counsel. Ms. Kowtoniuk added that while that section was deleted from the Senate version of the bill, it is still in the House version. She said that they will continue to keep an eye on it as it progresses.
- The COLA Commission has been extended to October 15, 2025. Ms. Kougias said that the purpose of the Commission is to study cost-of-living adjustments for members of the State Employees and State Teachers' Retirement Systems. The Commission is reviewing possible enhancement to the COLA for retirees and related costs and funding.
- There are approximately twenty-five policies pursuant to statuary and legal requirements to effectively administer the State Employees Retirement System. Ms. Kougias said that the Board Policy Committee has been convened to review and update the existing policies. The review will likely take several months followed by presenting to the Board for consideration before finalization.
- The HERO Act has been very successful and has brought a surge of work for the Buyback team.
 Through May, approximately 900 Military Buyback requests have been received in addition to the non-military applications. Upon receipt an acknowledgement letter is issued. Overtime was authorized to help address the increase in work. Although we would like to be able to send auto-updates to the members, this would require costly modifications to MARIS. Since it is a one-time process that is scheduled to end in August, 2025, it is not feasible to allocate resources at this time. A notification informing members about the longer timeline has been added to the website.

• The Salary Transparency outreach to payroll administrators has generated lots of activity and discussion with agencies. A second outreach effort is being planned for the June/July period.

Board & MSRB Communications

Ms. Kougias provided a summary of the warrants, accelerated payments and outreach. In-person visitors have been increasing steadily. She said that the number of monthly accelerated payments have been decreasing. With first payments being processed faster, there is less demand for the accelerated payments. Ms. Kougias also said that NFocus has proven to be a helpful telephone management tool. This ultimately improves customer service.

Legal Update

The legal update report was included in the Board materials. It included 7 summaries of recent administrative decisions as follows: Kahn v. SBR, CR-14-524 excess earnings; Mireault v. SRB, CR-17-168, heart law presumption; Fratto v. SRB, CR-24-0372, creditable service; Howard v. SBR, CR-23-0151, Group 2 classification; Crupi v. SBR, CR-25-0003, Group 4 classification; Budness v. SBR, CR-23-0488, accidental disability retirement; Santa v. SBR, CR-23-0413, Group 2 classification.
