Chair Larson opened the meeting at 9:03 a.m.

Commissioner Amidon reported many Earth Day events in the coming week, including MassWildlife public trout stocking events that he would be participating in.

Law Enforcement Comments

Captain Scott Amati reported that the MEP is focusing its work largely on spring recreational activities, including off-road vehicle use and other enforcement issues for the sister agencies. He provided the Board with an overview of actions connected to the current hunting and other recreational seasons and activities; a detailed report on recent OLE activities, including numerous fish-and-wildlife-related examples of calls for service that Environmental Police officers had responded to in the previous month, both inland and marine; and the outlines of ongoing and recently completed investigations of suspected violations and infractions.

The Chair thanked Captain Amati for his report.

Natural Heritage and Endangered Species Advisory Committee (NHESAC) Report

Chair Larson briefly touched on recent activities of Heritage staff and reported that he would provide the minutes to the last NHESAC meeting in January for more detail.

Set May Meeting Date

Director Tisa stated that he would like to plan an in-person meeting at the Field Headquarters in May and asked the Board members to consider scheduling the May monthly meeting during the week of May 23. He also asked that the members who are on the wildlife-damage subcommittee be prepared to meet with him on the same day. After some discussion, members set the date and time for the May Fisheries and Wildlife Board meeting on Tuesday, May 24, 2022, at 1:30 p.m., with the subcommittee meeting beginning at 9:30 a.m.

Member's Comments

Secretary Booth, Mr. Foster, and Dr. Van Roo reported no comments.

Mr. Durand noted that the new *Massachusetts Wildlife* issue was all fisheries- and aquatics-related and had a very good write-up for the proposed Swift River trout study.

Vice Chair Roche reported that he had been in Orange for the boat washing for the Quabbin. He asked whether the zebra mussel is a real scientific threat in Massachusetts, and particularly in the Quabbin. Director Tisa commented that he and the Chair were on the Governor's task force for zebra mussels, which included many stakeholders over more than a year of meetings, and he reported that MassWildlife has very little control over what is possible in the way of changes to the existing protocols and requirements.

Mr. Sears reported that the Berkshire County League's annual Silvio O. Conti Award dinner would be held the following Saturday and that Secretary Booth and her husband were planning to attend. He also reported that during its May meeting the Berkshire County League planned to host a presentation about the Swift River trout-tagging project. Mr. Sears also asked the other Board members to consider whether there is anything more they can do as a board to help the staff accomplish the agency's goals. He noted that he has been thinking about it and wanted to share the thought.

A motion was made by Vice Chair Roche to move into Executive Session for the purpose of discussing certain land acquisitions whose negotiations would be affected by discussion in open session and to return to open session afterward. The motion was seconded by Mr. Foster.

After a brief interval, Assistant Director Huguenin reported that he had compiled the amendments to the proposed regulations and he presented them to the meeting.

The first amendment was to set the Youth and Veteran/Active Duty Waterfowl hunt days on October 8, 2022, and February 4, 2023. Mr. Durand moved the amendment; Dr. Van Roo seconded the motion.
