The Deputy Director of the Massachusetts Firefighting Academy is deeply involved in other projects so Deputy Marshal Fournier will act as the interim Director.

Captain Paul Zipper, Commander of the Fire Investigation and Explosives Unit will be retiring mid-January. He has had a thirty two year career, many of them with the Department of Fire Services, and Marshal Ostroskey also wishes him the very best.

Deputy Marshal Fournier announced the upcoming cancer initiative which would involve providing CT scans for eligible firefighters for free through UMASS.
