A. Approval of Minutes of the October 16, 2018 Meeting

C. General Issues and Updates from DFS

Chief Nash began by updating the Commission that a draft of the FCAM recommendations regarding the credential and re-credential process will be released to the Commission in January.

State Fire Marshal Peter Ostroskey began by briefing the Commission about the budget and legislative process currently underway. The annual budget briefing will be scheduled as part of the February Fire Service Commission and Massachusetts Fire Training Council meetings.

Discussion regarding the proposal for the transfer of land from the Department of Corrections to the Department of Fire Services for a southeastern academy began. The site is 18 acres of land and includes existing classroom and building space. It would support a training yard and help relieve the wait list of over 200 for career recruit. Acquiring this third property would help manage the influx of new recruits. The property would also provide adequate space for training props for technical rescue training.

The Assistance to Firefighters Grant for a search and rescue prop for the Springfield site is just about the go out to bid.

The Department's Learning Management System (LMS) is proving effective for blended learning, data gathering, and has really allowed for the growth of our online course offerings.

The impact and support of the Merrimack Valley remains ongoing; new appliance fires, CO incidents, equipment repairs are all presenting problems. National Grid's gas service lock out is impacting alternate heating options.

Lastly, the Fire Safety Division hired a Fire Protection Engineer so the Department is now up to full complement of three (3) engineers.

D. Determination of Next Meeting Date and Adjournment

The date of the next meeting of the Fire Service Commission is tentatively scheduled on January 15th at 10:00 a.m. at the Department of Fire Services, Boards and Commissions Room.

A motion to adjourn was made by Chief Nash and seconded by Chief Roy. Said motion was approved by a unanimous vote of the Commission.
