## C. General Issues and Updates from DFS

Marshal Ostroskey explained that Fire Equipment Grant funds were released, and S.A.F.E. Grants awards were mailed out on February 16<sup>th</sup>.

There have been several fatal fires in the last four to six weeks although there are not a lot of commonalities. The Department has ramped up its public safety announcements.

The Fire Chiefs Association of Massachusetts Development Conference is to be held at the Worcester DCU Center March 1-3.

The Fire Investigation & Explosives Unit has gained three more members for the West, Central and North Teams.

The Deputy General Counsel and the Payroll Director positions are both moving forward. The Department is still advertising the MFA Director position and it is being publicized nationally. The posting will be open until the end of March.

Deputy Marshal Fournier updated the Commission on the CT scans which UMASS was forced to halt due to COVID-19. Hoping to begin testing again by the end of February.
