D. General Issues and Updates from DFS

Academy Director Jeff Winn introduced himself to the Commission. Deputy Fournier will be working very closely with Director Winn during this transition.

Marshal Ostroskey thanked EOPSS and Undersecretary Benincasa Thorpe for their support with the contractor rate chart increases which will attract and retain staff post pandemic.

January has been designated as Firefighter Cancer Awareness Month to raise awareness of this serious health and safety issue. DFS Staff will be wearing lavender shirts on Thursday's during the month of January 2023.

Code Compliance has been busy with new code roll out, holding six deliveries with more scheduled.

The ASHER director position has been posted. This position will have an MPTC equivalent and will work in conjunction with state, county, municipal, and regional law enforcement agencies, and will assist with standard training development to achieve an integrated preparedness, response, and recovery for active shooter or hostile event situations. A comprehensive training program will be prepared and rolled out to first responders.

Marshal Ostroskey continued to discuss other key positions that the Department is trying to fill; Director of Fire Safety Division; Deputy General Counsel; Deputy Director of Capital Asset Management; Public Education Coordinator; Chief Fire Protection Engineer as well as some key fiscal positions. The Deputy Director of Special Operations is in the final selection/hiring stages.

Deputy Fire Marshal Fournier explained that the annual budget presentation will be later than in previous years due to the new administration having additional time to prepare. Looking at a joint meeting with the MFTC during the March meeting.

Marshal Ostroskey announced his retirement effective June 30, 2023.
