## C. Correspondence from Chief Alan Roy

Chief Alan Roy presented a correspondence from Chief Michael Morrissey dated January 18, 2018 stating his intention to step down as the representative for call and volunteer as soon as is a replacement for him but no later than May 1, 2018.

Chief Alan Roy also brought up recent correspondences with the Massachusetts Call/Volunteer Firefighters Association in regard to H.2488- an act relative to the standards and qualifications for the position of fire chiefs in Massachusetts. They had a lengthy discussion regarding how to accommodate chiefs in small towns throughout the Commonwealth and have requested statistics to enhance future discussion.

#### D. General Issues and Updates from DFS

Deputy Marshal Fournier spoke about the recent discussion regarding fire evacuation routes due to an active shooter situations and that the Marshal is opposed to such devices as "door barricades". In conjunction with the Department of Professional Licensure, a two page document outlining compliant door options is expected to be released soon.

DFS is pleased to announce that Dennis Ball is the new full time recruit coordinator for the Massachusetts Firefighting Academy.

The Fire Safety division will be also be releasing information pertaining the Hotworks and requirements and policy for to obtain welding permits.

Lastly, as a result of the findings that came out of the Collin's report, the agency conducted a senior management workshop which was received well by staff and completes the list of recommendations
