Meeting called to order by Chairman Gregory Burns at 11:02 a.m.

Chief Burns began by congratulating Marshal Ostroskey on receiving the 2021 National Association of State Fire Marshal's (NASFM) award recognizing the Commonwealth's success in reducing child fire fatalities. The Commonwealth has not had a child under the age of 18 die in a fire in over two years.

A motion was made by FF MacKinnon Jr. and seconded by Chief Ingram to base the extension for the credentialing and re-credentialing program through December 31, 2021 on the application submission date.

# D. Firefighter Service Awards

Chief Burns briefed the Commission on the recent inquiry received regarding military time being used toward the Massachusetts Fire Service Awards. The Commission discussed the current criteria and proposed a few questions to be asked relative to the type of military classification the firefighter held during the years of service in question.

A motion was made by FF MacKinnon Jr. and seconded by Chief Archer to table until the response is received.

## E. General Issues and Updates from DFS

Marshal Ostroskey explained that the Department is in post-pandemic operations with full-time staff members reporting four days per week. The Fire Academy is working diligently to work on the backlog of MFA courses which were impacted by the pandemic.

The Fire & Life Safety Education Conference was held last week on the Cape and two DFS retirees were recognized; Jennifer Mieth, the Public Information Officer, and Cindy Ouellette, Coordinator for the Fire Data and Public Education Unit. The HazMat Tech Conference was also held in Plymouth and was another successful event.

The Department was involved with the Emergency Management Assistance Compact (EMAC) and sent ten firefighters from three departments to Louisiana for a fourteen-day deployment following Hurricane Ida.

The Marshal has requested that the Commission hold its next meeting at the Stow campus so they can be briefed on the Bridgewater campus' master plan.

## E. Determination of Next Meeting Date and Adjournment

The date of the next meeting of the Fire Service Commission is tentatively scheduled on October 21st at 10:00 a.m. in the Boards and Commissions Room at the Stow Campus.
