Meeting Summary:

- Welcome and Introductions
- Approval of Minutes of June 21, 2010 meeting
- Presentation by John Bynoe and Teri Williams Valentine on DESE Model Plan for Bullying Prevention and Intervention and DESE Proposed Regulations on Notification of Incidents of Bullying or Retaliation.
 - Final action on proposed regulations by the Board of Elementary and secondary Education is anticipated on September 21, 2010.
 - o DESE also continuing to work on providing evidence-based educational and professional development resources to schools and communities.
 - o DESE currently conducting a feasibility assessment to determine if they can offer a web-based etraining resource to schools.
- Mary Sullivan provided a review of some statistical information on bullying and cyberbullying.
 - Discussion of data from the Youth Risk Behavior Survey and also data from MARC (Massachusetts Aggression Reduction Center at Bridgewater State University)
- Maura Healy gave a brief synopsis of some criminal and civil laws (both in Massachusetts and in other states) which may apply to the issue of bullying. Summary sheet - Statutory overview was provided. It was noted that the summary is a preliminary compilation and is not exhaustive of all laws that may apply to bullying.
 - o Discussion that most states do not criminalize bullying.
 - o Juvenile courts already overburdened and under resourced.
 - Commission requested to review summary sheet and provide feedback at November 10th meeting.
 - o Commission's intent is to have parental involvement/prevention of bullying as a major focus, yet egregious cases (of bullying) must be dealt with seriously.
- Discussion of agenda for next meeting Wednesday, November 10, 2010 to include discussion of statutes, overview of the new harassment law and Massachusetts Civil Rights Act (MCRA) as both statutes can be used in some instances of bullying.
 - Also, will invite a bullying prevention expert such as Dr. Elizabeth Englander from MARC - to attend and to provide some information on bullying.
 - Ocommission is interested in hearing from teachers, principals and SROs people working in the field to give input/testimony. Also the Commission is mindful of the needs of potentially vulnerable populations (such as LGBT students, students of color, students with disabilities) and is working with a variety of advocacy groups to better understand the needs of those populations.
- There being no new business, the meeting was adjourned at 11:45 am.

- Invite experts to attend next meeting November 10, 2010 Nora Mann
- Create mechanism for receiving public comments/input regarding the charges of the Commission (via mail and via electronic transmission) Nora Mann
