ORDER TO SUBMIT ADDITIONAL EVIDENCE ON THE RECORD


Quaboag Riders, Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held an informational hearing on Tuesday, June 7, 2016, to determine if the Licensee's application for a change of manager of record should be approved or disapproved.

The investigator assigned to the application had recommended an informational hearing for the Commission to consider the character and fitness of the proposed manager of record, William D. O'Donnell, based on his Criminal Offender Record Information ("CORI"), of which there were several non-convictions.

Under 801 CMR 1.02(10)(h)(5), the Commission may "require any Party or the Agency, with appropriate notice to all other Parties, to submit additional evidence on any relevant matter" after a hearing. Based on the CORI presented to the Commission in the application, and after questioning of Mr. O'Donnell at the informational hearing, the specific dispositions of these criminal charges, including whether any of these non-convictions were continued without a finding, remains unclear. The Commission believes that review of the relevant docket sheets will provide the Commission with a better understanding of Mr. O'Donnell's CORI, and will aid and assist the Commission in its determination of whether to approve Quaboag Riders, Inc.'s application for a change of manager of record.

Accordingly, the Commission orders the investigator to produce any and all relevant docket sheets as they relate to Mr. O'Donnell's CORI, and will reopen the hearing record to admit in evidence these docket sheets, which will be marked collectively as Exhibit 1.
