MASSACHUSETTS PERMIT TO DISCHARGE POLLUTANTS TO SURFACE WATERS

In compliance with the provisions of the Massachusetts Clean Waters Act, as amended (M.G.L. Chap. 21, §§ 26 - 53) and the implementing regulations at 314 CMR 3.00 and 4.00,

Town of Montague 1 Avenue A Turners Falls, MA 01376

is authorized to discharge from the facility located at

Montague Clean Water Facility 34 Greenfield Road Montague, MA 01351

and

Combined Sewer Overflow (CSO) discharges at 2 locations

to receiving water named

Connecticut River (MA34-04)
Connecticut River Watershed

in accordance with the following effluent limitations, monitoring requirements and additional conditions:

- 1. The issuance date of this permit is the date it is signed by the Massachusetts Department of Environmental Protection (MassDEP).
- 2. This permit shall become effective on January 1, 2024.1
- 3. This permit shall expire five years after the effective date.
- 4. This permit supersedes the permit issued on September 22, 2008.
- 5. This permit incorporates by reference Part IA., Effluent Limitations and Monitoring Requirements, Part IB., Unauthorized Discharges, Part IC., Operation and Maintenance of the Treatment and Control Facilities, Part ID., Alternate Power Source, Part IE., Industrial Users and Pretreatment Program, Part IF., Sludge Conditions, Part IG., Special Conditions, Part IH., Combined Sewer Overflows (CSOs), Part II., Reporting Requirements, and Part II, Standard Conditions, as set forth in the 2023 NPDES Permit No. MA0100137, issued by the United States Environmental Protection Agency (EPA), Region 1, to the Permittee on October 19, 2023 (the 2023 NPDES Permit) and attached hereto by reference as Appendix A and available on EPA's website at https://www.epa.gov/npdes-permits/massachusetts-draft-individual-npdes-permits; provided, however:

¹ If no comments objecting to the issuance or terms of the permit were received by the Department during the public comment period, then this permit shall be effective upon issuance. If comments objecting to the issuance or the terms of the permit are received by the Department during the public comment period, then this permit shall become effective 30 days after issuance.

- a. that the notification required by Part IA.8. shall also be provided to massdep.npdes@mass.gov, or otherwise specified;
- b. that the reporting required by Part IB.1 shall be in accordance with 314 CMR 3.19(20)(e) (24 hour reporting);
- c. that a copy of the requests, reports, and information required by Part II.4 to be submitted to EPA shall also be submitted to MassDEP electronically to massdep.npdes@mass.gov;
- that, if there is a conflict between the definitions in 314 CMR 3.02 and/or 314 CMR 4.00 and the definitions in Part IIE, the definitions in 314 CMR 3.02 and/or 314 CMR 4.00 shall control, as applicable;
- 6. This permit incorporates by reference the Standard Permit Conditions set forth in 314 CMR 3.19.
- 7. The Permittee shall commence annual monitoring of all Significant Industrial Users^{2,3} discharging into the POTW using Draft Method 1633.
- 8. Notwithstanding any other provision of the 2023 NPDES permit to the contrary, all PFAS monitoring results (influent; effluent; sludge; SIUs; and specific industries as specified in the 2023 NPDES permit) shall be reported to MassDEP via the eDEP portal, or as otherwise specified, within 30 days after testing is complete, in addition to the 2023 NPDES Permit reporting requirements. Information regarding the submittal of data via eDEP may be found at https://www.mass.gov/how-to/submit-wastewaterresiduals-pfas-data-via-edep.
- 9. On or before January 31, 2024, the permittee shall submit to MassDEP at massdep.npdes@mass.gov a listing of all industrial dischargers with their addresses to be sampled in accordance with both the 2023 NPDES Permit and this permit and shall include:
 - a. All industries included in the categories listed the 2023 NPDES permit, Section IE. Industrial Users and Pretreatment Program, Paragraph 6; and
 - b. All Significant Industrial Users as required by Paragraph 7 of this permit.

The listing shall be maintained by the permittee and updated with any changes. Whenever necessary, a copy of the updated listing reflecting changes shall be forwarded to MassDEP at massdep.npdes@mass.gov on or before the next January 31.

The Town of Gill is a co-permittee for Part IB., Unauthorized Discharges; and Part IC., Operation and Maintenance of the Treatment and Control Facilities, as set forth in the 2023 NPDES Permit. In addition, these sections include conditions regarding the operation and maintenance of the collection systems owned and operated by the Town of Gill.

Operation and maintenance of the sewer system shall be in compliance with the General Requirements of Part II and the terms and conditions of Part IB., Part IC., and Part ID. of the 2023 NPDES permit. The Permittee and co-permittee are severally liable under Part IB., Part IC., and Part ID. for their own activities and required reporting with respect to the portions of the collection system that they own or operate. They are not liable for violations of Part IB., Part IC., and Part ID. committed by others relative to the portions of the collection system owned and operated by others. Nor are they

² Significant Industrial User (SIU) is defined at 40 CFR part 403: All industrial users subject to Categorical Pretreatment Standards under 40 CFR 403.6 and 40 CFR chapter I, subpart N; **and** any other industrial user that: discharges an average of 25,000 GPD or more of process wastewater to the POTW, contributes a process wastestream that makes up 5% or more of the average dry weather hydraulic or organic capacity of the POTW, or designated as such by the POTW on the basis that the industrial users has a reasonable potential for adversely affecting the POTW's operation or for violating any Pretreatment Standards or requirement.

³ This requirement applies to all Significant Industrial Users and not just those within the sectors identified by EPA in the NPDES permit.

RESPONSE TO COMMENTS

MA Permit No. MA0100137 Montague Clean Water Facility 34 Greenfield Road, Montague, Massachusetts 01351

The Massachusetts Department of Environmental Protection (MassDEP or the "Department") is issuing a Surface Water Discharge (SWD) Permit for the Montague Clean Water Facility. The permit is being issued under the Massachusetts Clean Waters Act, as amended (M.G.L. Chap. 21, §§ 26 - 53) and the implementing regulations at 314 CMR 3.00 and 4.00.

In accordance with the provisions of 314 CMR 2.09, MassDEP is obligated to prepare a response to comments received on the draft SWD Permit No. MA0100137 (the "Draft Permit"). The Response to Comments explains and supports MassDEP's determinations that form the basis of the final permit (the "Final Permit"). From March 30, 2023, through May 12, 2023, MassDEP solicited public comments on the Draft Permit for the reissuance of a permit to discharge wastewater from Outfall Serial Number 001 to the Connecticut River and the associated Draft Water Quality Certificate.

During the public comment period for the draft NPDES permit (March 30, 2023, through May 12, 2023), EPA received comments from the following:

- 1. Town of Montague Selectboard, dated May 12, 2023
- 2. Connecticut Department of Energy and Environmental Protection, dated April 8, 2023
- 3. Connecticut River Conservancy, dated May 12, 2023
- 4. The National Association of Clean Water Agencies (NACWA), dated May 12, 2023
- 5. Massachusetts Water Resources Authority, dated May 10, 2023

During the public comment period for the draft SWD Permit, MassDEP received identical comments as those submitted to EPA from:

- 1. Town of Montague Selectboard, dated May 12, 2023
- 2. Massachusetts Water Resources Authority, dated May 10, 2023

MassDEP has reviewed EPA's Response to Comments, issued concurrent with the final NPDES permit on September 28, 2023, and concurs with their responses and the associated adjustments made to the final NPDES permit. MassDEP hereby incorporates by reference EPA's Response to Comments into this Response.

MassDEP's knowledge of the facility has benefited from the various comments and additional information submitted during the public comment period, but the information and arguments presented did not raise any substantial new questions concerning the Permit that warranted MassDEP exercising the discretion to reopen the public comment period. MassDEP does, however, make certain clarifications in response to comments. Any improvements and changes are explained in this document and reflected in the Final Permit. Below, MassDEP provides a summary of the changes made in the Final Permit.

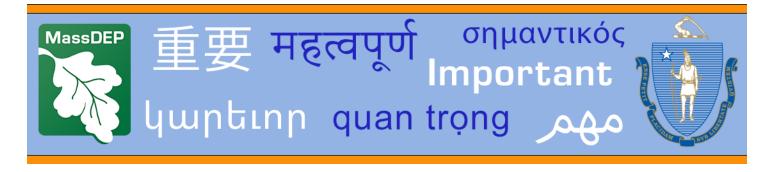
