Re: <u>Request for Information</u>

Dear Mr. Moskol:

This letter is to inform you that the Medical Use of Marijuana Program ("Program") at the Cannabis Control Commission ("Commission") has reviewed Bloominus, Inc.'s *Management and Operations Profile* (Application 1 of 2). The *Management and Operations Profile* requires the following information before the Program may complete its evaluation:

- 1. The applicant did not submit its bylaws as required under Section B of the Management and Operations Profile. Please submit a copy of the applicant's bylaws.
- 2. In its response to Question D.20, the applicate states Bruce Dean worked for Northeastern University, but his Employment and Education Form does not include this employment. Please clarify whether Bruce Dean has worked for Northeastern within the past 10 years. If so, please include this information in his Employment and Education Form and resubmit the form.
- 3. In its response to Question E.24, the applicant states, "The alarm system will at a minimum include: a perimeter alarm at all entry points and windows..." Pursuant to 935 CMR 501.110(4)(a)1, a RMD shall have, at a minimum, "a perimeter alarm on all entry *and exit* points and perimeter windows [emphasis added]." Please resubmit a complete response to Question E.24 that is in compliance with 935 CMR 501.110(4)(a)1.
- 4. In its response to Question E.29, the applicant states, "All marijuana will be tested for...the presence of non-organic pesticides." Pursuant to 935 CMR 501.105(3)(b)(1), "Marijuana shall be tested for...the presence of pesticides." Please further note, 935 CMR 501.105(2)(b) requires that "application of pesticides shall be performed in compliance with M.G.L. c. 132B and 333 CMR 2.00 through 333 CMR 14.00." Please resubmit a response to Question E.29 that is in compliance with the regulations regarding pesticides.

If the applicant has been requested to resubmit their response to a question, please do so using the page on the application form for that particular question, and include an initialed attestation at the bottom of the page. The applicant need not resubmit the entire application and may submit only the page for the particular question that needs to be submitted.

Please remember to type all responses in the information or materials resubmitted to the Program, other than any required signatures, as well as include the name of the Applicant Corporation *and* the number of the application (e.g., Application 1 of 1) at the top of each page of the resubmitted information or materials.

Upon receipt, the Program will review the information and will notify the applicant if it is invited to submit a *Siting Profile* or if further information is required before the applicant may proceed.
