**Purpose:** To notify Local Workforce Investment Boards, One-Stop Career Center

Operators and other local workforce investment partners regarding MOSES 34.4

scheduled for release to the desktops on Friday, January 23, 2015.

**Background:** The release date to the field for MOSES 34.4 is Monday, January 26, 2015.

This will be a weekday night-time build.

MOSES will be shut down at 4:30 p.m. on Friday, January 23, 2015 for the updates and the maintenance of the MOSES software and MOSES Applications (JobQuest / TrainingPro).

This will **NOT** interrupt other IT services or functions to the offices, only MOSES will be taken off-line. Email, unemployment assistance systems and internet services will still be available.

Please plan on completing and saving your MOSES data entry by 4:15 p.m. on Friday, January 23, and then log off MOSES. This will ensure that when you

log into MOSES on Monday, January 26, you will have the new version of MOSES available and any work done prior will be saved.

**Required:** Local Workforce Investment Boards, Career Center operators, and workforce

partners should ensure that all staff are aware of the MOSES changes and that all MOSES users plan their workloads accordingly in preparation for MOSES to shut

down at 4:30 p.m. on January 23, 2015.



## **Description of Changes in MOSES Version 34.4**

## The key MOSES 34.4 changes are:

#### 1. Requirements for Collection of Race/Ethnicity Data: Policy Issuance 14-111


The U.S. Department of Labor, Employment and Training Administration in its Consolidated Compliance Review conducted during June and July 2014, issued a finding regarding collection of race/ethnicity data. 29 CFR Part 37.37(d) ("Implementation of Nondiscrimination and Equal Opportunity Provisions") states: "Where designation of individuals by race or ethnicity is required, the guidelines of the Office of Management and Budget (OMB) must be used." OMB Statistical Directive No. 15, adopted October 30, 1997, includes specific racial categories and requires that ethnicity be captured prior to and separate from race. DOL found that MOSES was not in compliance. The ethnicity question must be asked prior to and separate from race. The ethnicity question should provide two options: Hispanic or Latino and Not Hispanic or Latino. The race categories shall provide the following options: American Indian or Alaska Native, Asian, Black or African American, Native Hawaiian or Other Pacific Islander, and White.



### 2. Job Seeker – Military Information tab changes

The Branch information is now added or updated on a popup screen as shown below by using the ADD or EDIT buttons.

The DD214 verification is now associated with each specific stint in the Military.



The DD214 Verified is not a required field, but when it is checked and the OK button is clicked a popup box will appear asking if you want to enroll the applicant in the Veterans Program.
