## MOTION TO ACCEPT RECEIVER'S FINAL ACCOUNTING AND FINAL REPORT, APPROVE FORECLOSURE SALE AT PUBLIC AUCTION, AND DISCHARGE RECEIVER

NOW COMES, the Receiver, [NAME], (Receiver') and hereby moves this Honorable Court to enter an Order accepting the Receiver's Final Accounting and Final Report, approving the Receiver's February XX, XXXX foreclosure sale at public auction regarding the premises located at [ADDRESS], Massachusetts, and discharging the Receiver upon the recording of the foreclosure deed in the Bristol County (F.R.)
