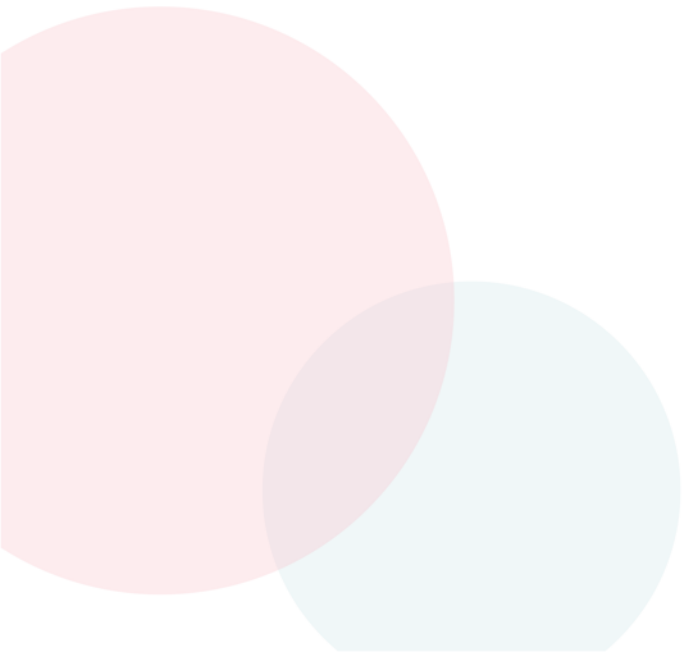


Massachusetts Disability Employment Tax Credit

Massachusetts Rehabilitation Commission



What is the DETC?

- A tax incentive for employers to hire individuals with disabilities.
- Made available in the FY'22 Budget, Section 37.
- Employees must work for a Minimum of 12 Months.
- Provides \$5,000.00 or 30% credit, per employee – 1st year.
- Provides \$2,000.00 or 30% credit, per employee – subsequent years
- MRC collaborated with EOHHS to create regulations and establishing an application process
- MRC must provide certification to the employee who in turn, will give a copy to the employer, for use when filing their tax return with the Department of Revenue.

What has been accomplished?

- Regulations written - Approved by EOHHS
- Drafted criteria and process to determine consumer eligibility
- Developed online Certification Form
- Identified Tax Credit Coordinator
- Established a dedicated email address, DETC@mass.gov
- MRC Communications Department is coordinating a marketing strategy – Brochure, Landing Page, Press Releases
- RFR for Marketing Consultant

DETC Eligibility Process

- Applicant completes on-line DETC Certification Form
- Completed applications are stored in a central electronic location and an email is generated to alert the DETC Coordinator that an application is waiting to be processed.
- Within two business days, the DETC Coordinator will review the Certification Form and supplemental materials and respond to the applicant regarding the status of their certification.

DETC Eligibility Process

- If the Certification Form is complete and all the materials are in order, the DETC Coordinator will forward a copy of the Certificate of Eligibility to the Qualified Employee, which may be given to the employer for use when filing their Massachusetts Tax Return.
- If the Certification Form or supplemental materials are not complete, the DETC Coordinator will notify the applicant and explain what is needed to approve the Certification Form.
- After the applicant provides the requested materials, the DETC Coordinator will forward a copy of the Certificate of Eligibility to the Qualified Employee.

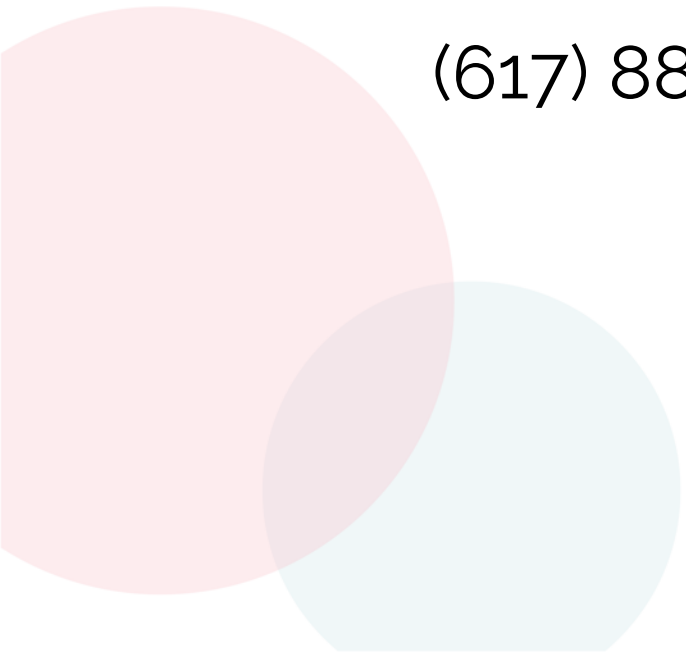
- Public Hearing – February 28, 2023
- Finals regulations – Released April 4, 2023
- Credit may be claimed beginning January 1, 2023
- Commissioner of DOR and the Secretary of EOHHS intend to issue further guidance on the credit (establishing an application process)
