## MS4 Grant Question and Answer Document August 30, 2024

On July 26, 2024, the Massachusetts Department of Environmental Protection (MassDEP) announced the 2024-2025 Opportunity for the MS4 Municipal Assistance Grant Program (Grant Program). Below are MassDEP's official Answers to all questions received by the August 16, 2024, deadline. The questions below reflect those received both during the August 5, 2024, Pre-Application Meeting, and via email as identified in Sections 1.J. and 1.K. of the RFR.

A recording of the Pre-Application Meeting is unavailable due to a technical difficulty. In lieu of a recording, the following meeting minutes have been provided.

The August 5, 2024, Pre-Application Meeting Began at 10:03 A.M. and concluded at 10:20 A.M.

**Elizabeth Clark, MassDEP**: Provided a brief grant program overview to meet MS4 permit requirements and described eligible entities as described in the RFR. Many prior projects were to meet education requirements and develop tools. Ms. Clark identified that projects cannot duplicate past work. Ms. Clark summarized that applications are due on September 6, 2024, and the program is funded at \$250,000 and awards may range from \$50,000-\$250,000. No match is required, but it may be considered during the evaluation of the grant.

**Courtney Starling, MassDEP:** Provided an overview on contract terms, the potential for reimbursements for project costs prior to grant award. Pointed out evaluation criteria on Pg. 5 of application. Reiterated the need to partner for collaborations. Reiterated submission instructions as identified in the RFR. Pointed out Attachment A and cautioned that the Application format is required. Provided overview of budget table to break project down by milestone and responsible party.

## **Questions & Answers (Pre-Application Meeting):**

### Question 1: What is the goal of having the towns work together? Same watershed?

Answer 1: The goal of encouraging towns to work together is to develop and share resources among as many permittees as possible to maximize the impact of the funding.
