2. Hearing in the matter of: Michael Guy BXPB-004151 re: contest MSAC21-0699 Mass Mutual Center on November 27, 2021

An evidentiary hearing was held in the Matter of Michael Guy. The Commission heard sworn testimony from the following witness: Peter Q. Warinner, M.D., Mr. Otis Griffin, and Mr. Artie Depino and received in evidence: the notice of hearing and suspension, dated March 29, 2022 (Exhibit A), the respondent's rebuttal, dated March 23, 2022 (Exhibit B), the Quest analysis of sample dated December 15, 2021 (Exhibit C) and World Anti-Doping Agency, International Standard Prohibited List, effective January 1, 2021(Exhibit D).



Following the conclusion of the hearing, Commissioner Lambert moved to exit open session and enter closed session for the purpose of conducting an adjudicatory conference pursuant to G. L. c. 30A, § 18, ¶ 5(d), thereupon to adjourn. The motion was seconded by Chairman Karger and passed by a unanimous voice vote.
