The meeting was called to order at 11:03 AM

1. Roll Call

2. Review/ Vote MSAC minutes for June 2, 2022

#### 3. Applications

1. Review of Manager for MMA application for Christopher Chambers.

Mr. Chambers was not available for comment in reviewing his application. A call was placed to him at his provided number, but he did not pick up nor call back. A vote was not taken on this application.

2. Review of Manager for Boxing application for Albert Arcand

A call was placed to Mr. Arcane as he was not present in person at the meeting. He did not pick up initially but called back a minute later. After a brief discussion of Mr. Arcand's qualifications and history with Boxing over the phone, Commissioners inquired related to Mr. Arcand's familiarity with 523 CMR Section 9, related to managers. The applicant indicated he had not reviewed that part of the regulations. The application was tabled to the 7/20 MSAC Meeting.

While waiting on a call from Mr. Zerr to review his application, a discussion was had regarding Mr. Kent's Lion Fight promoter's license. Matters concerning the latest date the completed application can be processed were discussed. Mr. Zerr called back during the conversation, and the discussion was tabled to the end of the meeting.

3. Review of Matchmaker for Muay Thai application for Scott Zerr.

After a brief discussion of Mr. Zerr's qualifications (Exhibit B) and history with Muay Thai over the phone, a **Motion** was made by Oded Carmi to approve the application and **Seconded** by Dave Riccio. A **Roll Call** vote was taken where Paul Karger voted **YES**, Bryan Lambert voted **YES**, Oded Carmi voted **YES**, Dave Riccio voted **YES**, and Brian O'Connell voted **YES**. The motion passed **Unanimously**.

5. Other matters not reasonably anticipated 48 hours in advance of meeting.

Michael Reyes presented his variance requests for the 7/9 A Fighting Chance Inc Bout (Exhibit D). As the variances were not in a format that directly requested the specific relief from specific regulation requirements the Commission allowed Mr. Reyes to resubmit his variance requests in the proper manner via email to staff and be reviewed/voted on at the 6/13 MSAC Meeting that will be held via Teams.

A discussion of the authority the MSAC Commission members have when attending sanctioned fights was begun. The Commission asked staff to elaborate on the roles and responsibilities of individual Commissioners, Deputy Commissioners and compliance officers at events and exhibitions. There was a suggestion to create an inspector license to assist in monitoring events along with the Deputy Commissioners, Commissioners, and Staff that attend the events to mitigate staffing issues and provide more flexibility in addressing matters as they come up at events.

Regarding Mr. Kent's application, The Commission determined the application was incomplete by not having an executed bond. A **Motion** was made by Brian O'Connell to table the Lion Fight application for consideration on the 6/13 MSAC meeting. **Seconded** by Dave Riccio. A **Roll Call** vote was taken where Paul Karger voted **YES**, Bryan Lambert voted **YES**, Oded Carmi voted **NO**, Dave Riccio voted **YES**, and Brian O'Connell voted **YES**. The motion **Passed** 4/1.
