# 2. Approval of Minutes from May 21, 2018 and May 25, 2018

Commissioner Karger made a motion to approve the minutes from May 21, 2018 and May 25, 2018, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

# 3. Application for Promoter - Yvonne Grealish

Applicant Yvonne Grealish detailed her experience as a boxing gym owner and previously licensed boxing promoter over the last 30 years. Mrs. Grealish is looking to provide events for her boxers to participate on; her proposed venue is the Dorchester Armory. Commissioner Karger made a motion to approve the application for promoter, seconded by Commissioner Borstel. Motion was passed by unanimous vote.

#### 4. Application for Judge –Ernest Forte

Applicant Ernest Forte detailed his experience as a boxing judge under the jurisdiction of USA Boxing New England over the last 25 years as well as a former Deputy Commissioner for the Massachusetts State Athletic Commission. Commissioner Borstel made a motion to approve the application for judge, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

## 5. Application for Referee – Daniel J. Miragliotta III

Applicant Daniel J. Miragliotta III detailed his experience as a mixed martial arts and muay thai referee throughout the country. Commissioner Borstel made a motion to approve the application for referee, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

6. <u>Approval of "Amateur Unarmed Combatant Medical Waiver/Informed Consent" Form</u> Commissioner Lambert made a motion to accept the "Amateur Unarmed Combatant Medical Waiver/Informed Consent" Form as written, seconded by Commissioner Karger. Motion was passed by unanimous vote.

## 7. Fee schedule for alternate Ringside Physician at weigh-in

Matthew Keigan, Executive Director of Licensing presented an adjustment to the 60/40 fee schedule set for Ringside Physicians working the events and weigh-ins. Most Recently, either doctor set to work an event were both unable to work the weigh-in; MSAC staff scheduled an alternate physician to staff the weigh-in and divided the fee schedule three ways. The two physicians working the event received \$400.00 each while the alternate doctor working the weigh-in received \$200.00; keeping within the \$1,000.00 fee schedule. This resolution was presented to the board for approval for further instances when the two scheduled physicians are not available to work the weigh-in. Commissioner Borstel made a motion to accept the adjustment in the fee schedule, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

#### 8. Review of MSAC Applications

MSAC staff presented the newly revised program applications to the board for review and approval.

### **Professional Fighter Application**

Commissioner Borstel made a motion to approve the professional fighter application pending the addition of language regarding the acceptance of medicals from other jurisdictions, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

#### Amateur Fighter Application

Commissioner Karger made a motion to approve the amateur fighter application pending the addition of language regarding the acceptance of medicals from other jurisdictions, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

#### Pro debut Fighter Application

Commissioner Borstel made a motion to approve the pro debut fighter application pending the addition of language regarding the acceptance of medicals from other jurisdictions, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

#### Promoter Application

Commissioner Borstel made a motion to approve the promoter application pending further research from legal counsel on the good moral character clause and how it can be incorporated into the application as well as if the program can run criminal backgrounds on the applicants, seconded by Commissioner Karger. Motion was passed by unanimous vote.

#### Matchmaker Application

Commissioner Borstel made a motion to accept the matchmaker application as written, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

#### **Manager Application**

Commissioner Borstel made a motion to accept the manager application as written, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

#### Ringside Physician Application

Commissioner Lambert made a motion to accept the ringside physician application as written, seconded by Commissioner Karger. Motion was passed by unanimous vote.

Commissioner Borstel made a motion to amend the approval of the professional fighter application to include a question regarding the training regimen of the fighter, seconded by Commissioner Lambert. Motion was passed by unanimous vote.

Commissioner Borstel made a motion to table the remaining applications until the next board meeting in the interest of time, seconded by Commissioner Lambert. Motion was passed by unanimous vote.
