### 3% COLA Proposed for FY'20

A proposed 3% COLA (Cost-of-Living Adjustment) increase for eligible retired state employees has been included within all the current FY'20 state budget proposals. If enacted by the Legislature, the COLA will go into effect on July 1, 2019, for those eligible members who were retired before July 1, 2018. The adjustment would be based on the first \$13,000 of your pension benefit and would equal a maximum annual increase of \$390.

## Did You Know?

If you receive a superannuation retirement benefit for at least one full calendar year and work in the public sector within Massachusetts, you can now earn the difference between the current salary of the position you retired from and your pension, plus an additional \$15,000. Please note, rules about the maximum 960 hours eligible retirees can work in a calendar year still apply. # State Treasurer's Unclaimed Property Division

The Unclaimed Property Division of the Massachusetts Treasury connects citizens with their abandoned property such as bank accounts, uncashed checks, stocks or dividends, insurance policies, or the contents of safe deposit boxes. They have paid out over \$225 million over the last two years.

State Treasurer Deborah Goldberg has announced that the Unclaimed Property Division is holding over \$2.4 billion in unclaimed funds for the citizens and businesses of the Commonwealth. The Division holds these lost funds until they are claimed by either the original owner or their heirs. Claiming property is fast, easy and free.

#### **WEP Repeal Update**

In the fall, the *Retiree eNews Bulletin* reported that new federal legislation was filed on September 27, 2018, and if passed, would mark the first step toward resolving the unfairness of the Social Security Windfall Elimination Provision (WEP) since the law's creation in 1983.

Since then, our office has received many inquiries about the current status of the legislation and if there is anything they can do to support it. The Bill, H.R. 6933, which is cosponsored by House Ways and Means Chairman Kevin Brady (R-TX) and Committee's Ranking Member Richard Neal (D-MA), was referred to the Subcommittee on Social Security on October 10, 2018, and no further action has occurred since then.
