

Federal Legislation to Modify Social Security WEP Formula Reintroduced

United States House of Representatives Ways and Means Committee Chairman Richard E. Neal (D-MA) recently reintroduced his legislation to modify the Windfall Elimination Provision (WEP) for future retirees and provide relief to current WEP retirees.

The Public Servants Protection & Fairness Act of 2021 would establish a new formula that would pay Social Security benefits in proportion to the share of a worker's earnings covered for Social Security purposes. The provision is coupled with a proposed benefit guarantee that would ensure no benefit cuts relative to current law for all current and future retirees. Current WEP retirees would receive \$150 a month in relief payments.

Benefit Verification Form (BVF) Process Nearly Complete

As we approach the completion of the 2020 Benefit Verification process the MSRB would like to thank all of our retirees who returned their forms!

For those retirees from whom we have not yet received a valid BVF, MSRB staff is making efforts to contact them.

Beginning on April 30, 2021, those retirees who have not verified their eligibility and returned a properly completed BVF will notice an interruption of benefit payments.

This interruption of a monthly pension benefit may also impact retiree health and life insurance coverage.

If you have previously submitted a valid 2020 BVF, you would have received confirmation from the MSRB. If you are not sure why your BVF was rejected, or if there is a reason prohibiting you from completing this form, please contact our office immediately at (617) 367-7770.

Post Retirement Work Waiver During the State of Emergency Extended to 2021

The waiver of earnings and hours restrictions for superannuation (regular retirement) public retirees working in the public sector has been extended into calendar year 2021.

As in 2020, the waiver is in place for the duration of the Governor's State of Emergency, or the end of Calendar Year 2021, whichever occurs first. The Board receives many questions about knowing when the State of Emergency ends. It will be an official declaration made by the Governor.

It should be noted that the legislation does not apply to disability retirees who must continue to comply with the annual earnings limitations of Section 91 and Section 91A. You may also email us.

PLEASE BE ON ALERT FOR FRAUD:

Be aware of questionable emails related to your retirement benefits. Scammers capitalize on "hot news topics," such as the Coronavirus, to trick you into clicking on their websites and emails.

- Always first check the sender's email address to look for grammatical errors or questionable spellings;
- Emails from the State Retirement Board will ALWAYS come from staff that end with <u>@tre.state.ma.us;</u>
- The MSRB will NEVER ask you for personal information via email or ask you to send such information via email. Please don't ever email your full social security number.

Turning Age 65 and Medicare Enrollment with GIC Health Coverage

Did you know, the GIC's website provides information to help members understand if and when to enroll in Medicare Part A and Part B if you have GIC health coverage? They also have a video on the subject. Visit: <u>Turning age 65 and Medicare</u> <u>enrollment with GIC health coverage |</u> <u>Mass.gov</u> Retirees should consult with their employers regarding their earnings limits and how the legislation will impact it. Retirees should also check directly with the appropriate bargaining unit if you are working in a union benefitted position as a retiree as restrictions may apply.

The exclusion only applies to public retirees who are seeking to or already work in a public position (e.g., State, county, or municipality). Those who work in the private sector, government jobs outside of Massachusetts, or the federal government are not impacted by the limits of MGL Chapter 32, Section 91.

MSRB staff will continue to monitor the situation and will update its website and notify retirees if the Governor takes such action.

PRIM Update as of February 2021

The Pension Reserves Investment Management Board (PRIM) manages the assets of the Massachusetts State Employees' Retirement System ("MSERS") along with the assets of more than 90 other Massachusetts public employee retirement systems. PRIM is chaired by Treasurer Deborah B. Goldberg, who also chairs the State Retirement Board.

At the end of February 2021, PRIM's total fund value stood at more than \$87 billion, of which \$32.7 billion are assets of the MSERS and \$170.1m represented assets of the former Massachusetts Turnpike Authority Employees Retirement System.

Social Security Number Safety: Do Not Email Your Entire Social Security Number to Anyone

The Retirement Board has received inquiries and e-mails where members are adding their full Social Security numbers or other personally identifiable information to their message. We want to remind you that such information is susceptible to being stolen when transferred over the Internet and we strongly encourage you not to include it when emailing the MSRB. Exposing such information puts you at risk of identity theft and scams. The MSRB will never need your full Social Security number through e-mail.

Instead, you can use your MSRB Member ID number, which can be found on most correspondence from the MSRB. In today's technological climate, it is more important than ever to keep your identity protected online.
