# COVID-19 Over-the-Counter (OTC) Tests

As of Monday, April 4, 2022, Medicare announced that it would cover up to 8 over-the-counter COVID-19 tests each month, at no cost to the individual. This benefit applies to individuals who have Medicare Part B.

Individuals won't have to pay as long as they go to an eligible pharmacy or healthcare provider. The Medicare website provides a <u>partial list of pharmacies</u> participating in this program.

Medicare also has stated that it will cover tests that are provided by laboratories, pharmacies, doctors, hospitals, and when a doctor or other authorized health care professional places an order for the test.

The Pension Reserves Investment
Management Board (PRIM) manages the
assets of the Massachusetts State
Employees' Retirement System
("MSERS") along with the assets of more
than 90 other Massachusetts public
employee retirement systems. PRIM is
chaired by Treasurer Deborah B.
Goldberg, who also chairs the State
Retirement Board.

At the end of March 2022, PRIM's total fund value stood at more than \$101 billion, of which \$37 billion are assets of the MSERS and \$179 million represented assets of the former Massachusetts Turnpike Authority Employees Retirement System.

In a recent press release from Kilolo Kijakazi, the Acting Commissioner of the Social Security Administration (SSA), it was announced that local Social Security offices would have their in-person services restored as of April 7, 2022.

Individuals may still use the <u>Social</u> <u>Security Website</u> or phone number to reach out to a member of their staff.

The SSA also reminds everyone that Social Security offices "tend to be the busiest first thing in the morning, early in the week, and during the early part of the month."

In the posting, they recognize that there have been technical issues with the SSA's 800-number. Due to these issues, they have announced that anyone who was unable to enroll or disenroll will be granted additional time through December 30, 2022.
