

## 2022 IRS Form 1099-R Update

The 2022 Form 1099-R's have been mailed and will be viewable on your PayInfo account in mid-February.

Please allow ample time for your Form 1099-R to be delivered via the United States Postal Service ("USPS"). You can view the USPS Service Alerts regarding mail delivery and how it may affect your area <u>by clicking here</u>.

If you are still waiting to receive your Form 1099-R by mid-February, you can call our office at 617-367-7770. If you need to request a duplicate 1099-R from the Board, you can do so beginning on February 13, 2023.

Please note: Although this is a handy item to have available for reference, the copy on PayInfo is not considered an official Form 1099-R and cannot be used to file your taxes. Therefore, hold on to the original hard copy that was mailed to you.

#### *Important reminder for those who turned age 59 ½ during 2022:* most of you will receive TWO Form 1099-R's! One is for members who received a monthly retirement benefit before turning age 59 ½ in 2022, and the second is for those after age 59 ½. Please be advised that most of you will receive two Form 1099-R's. (PayInfo can only display ONE Form 1099-

#### IRS Federal Withholding Tables Updated for 2023

With the start of 2023, the Board has applied the new federal withholding tables released by the IRS. Please review your monthly withholding amounts to determine if they are appropriate for you.

### MSRB Executive Director Steps Down After Nearly 20 Years of Service

On January 6, 2023, Treasurer Goldberg announced that the Executive Director of the Massachusetts State Retirement Board ("MSRB"), Nicola "Nick" Favorito, stepped down for a role outside of state government.

Mr. Favorito has served as executive director since February 2003. He also served as a Deputy Treasurer. Mr. Favorito has been hired as the new executive director for the North Atlantic States Carpenters Benefits Fund ("NASCBF"). R.) The retirement allowance paid up until the month before you turned age 59 ½ will be reported on one Form 1099-R using distribution code 2, and the retirement allowance paid for the remainder of the year will be reported on a second Form 1099-R using distribution code 7. Information from both forms should be used for tax reporting purposes.

Additionally, due to the technical limitations of PayInfo, it can only display one Form 1099-R. PayInfo displays Form 1099-R's for members who received a monthly benefit in 2022. It does not display refund Form 1099-R's.

### **Post-Retirement Work Update**

Please be advised that the waiver on Post-Retirement Work expired on December 31, 2022. Therefore, the laws related to working and receiving a retirement benefit are in effect for the calendar year 2023.

As a reminder, those receiving a superannuation retirement benefit and working in the public sector must stop working if they have worked 1,200 hours in a calendar year and/or earned the difference between the current salary of the position they retired from and their pension. After being retired for one full calendar year, they can earn an additional \$15,000.

Those receiving a superannuation retirement benefit and working in the private sector are not limited in hours or earnings. *However, all disability retirees are subject to earning limits.*

## 2023 Medicare Premium News

Earlier last year, the Centers for Medicare & Medicaid Services ("CMS") announced that Medicare Part B's Premium would decrease from \$170.10 in 2022 to \$164.90 this year. In addition, the annual deductible has been reduced from \$233 in 2022 to \$226 this year.

<u>CMS also announced</u>, in July, that the average premium for Medicare Part D would likely decrease by 1.8% in 2023, from \$32.08 to \$31.50.

As deductions are typically taken directly from someone's Social Security benefit, those receiving Social Security may see an increase in their checks due to the adjusted premiums.

on Monday, January 23, 2023. For most taxpayers, April 17, 2023, is the deadline to file or request an extension.

The IRS notes that for Massachusetts and Maine taxpayers, the deadline is April 18, 2023, due to the Patriots' Day holiday. Those requesting an extension will have until Monday, October 16, 2023 to file.

The IRS offers a free and reliable source for filing your federal income taxes called Free File.

## The Affordable Connectivity Program

The Federal Trade Commission oversees the *Affordable Connectivity Program (ACP)*, a benefit that provides households with discounts on internet service costs or even buying a laptop, tablet, or desktop computer.

You may be eligible for the ACP benefit if your household income is below 200% of the Federal Poverty Line or if you or someone you live with receives a benefit such as Medicaid, SNAP, SSI, WIC, Pell Grant, or Free and Reduced-Price Lunch.

If shown to be eligible, a household could receive the following:

- Up to \$30/month off their internet service;
- Up to \$75/month off if the household is on qualifying Tribal lands;
- A discount of up to \$100 on a tablet, tablet, or desktop computer;
- A low-cost service plan that may be fully covered through ACP.
