MSRB Special Announcement

Due to the ongoing general public health concerns, we wanted to remind you of some changes to day to day operations at the Retirement Board's Boston and Springfield offices.

To try and reduce risk and opportunities of exposure, beginning on Monday, March 16, 2020, the Board modified its available onsite workforce to permit some staff to work remotely. We will continue our regular hours of operations at both office locations.

Please note: the reduced staffing will not impact the issuance of monthly benefit payments scheduled for March 31, 2020.

More importantly, we will be suspending in-person visits by active and retired members for the time being and ask that all retirement benefit related questions be addressed by email or by telephone.

PLEASE BE ON ALERT FOR FRAUD:

Be aware of questionable emails related to your retirement benefits. Scammers capitalize on "hot news topics," such as the Coronavirus, to trick you into clicking on their websites and emails.

- Always first check the sender's email address to look for grammatical errors or questionable spellings;
- Emails from the State Retirement Board will ALWAYS come from staff that end with @tre.state.ma.us;
- The MSRB will NEVER ask you for personal information via email or ask you to send such information via email. Please don't ever email your

information to their message. We want to remind you that such information is susceptible to being stolen when transferred over the Internet. It puts you at risk of identity theft and scams and is just as dangerous as putting your number on a postcard through the mail. The MSRB will never need your full Social Security Number through e-mail.

Instead, you can use your MSRB Member ID number, which can be found on most correspondence from the MSRB.

Please be careful in providing any of your personal information through e-mail. In today's technological climate, it is more important than ever to keep your identity protected online.

On New Year's Day 2020, State Treasurer Deborah Goldberg kicked off her BabySteps Savings Plan, the first Massachusetts statewide college and vocational training savings program. Every child born or adopted in Massachusetts on or after January 1, 2020, is now eligible for a free \$50 deposit into a post-secondary education savings account.

All new parents and/or guardians in Massachusetts will have up to one year after the child is born or adopted to open a U.Fund 529 college savings account in order to receive the \$50 deposit. The program encourages families to save for future learning, fosters aspirations of higher education, and delivers free financial education resources and tools to all program participants.

"With rising costs, the path forward is unclear for many of our kids," said Treasurer Deborah Goldberg. "BabySteps will encourage thoughtful planning for higher education and vocational training for children across Massachusetts."
