## Homebound COVID vaccination effort begins March 29, 2021

As recently announced by the Massachusetts Department of Public Health, individuals who face significant difficulties getting to a pharmacy, health care center or one of the state's mass vaccination sites, those who require an ambulance or two-person assistance to leave home, and those who could not leave home for medical appointments before COVID-19 will qualify to receive doses where they live.

Homebound residents or their loved ones can call 1-833-983-0485 to begin the process of scheduling an in-home vaccine appointment. The line will be open Monday through Friday from 9 a.m. to 5 p.m., available in English and Spanish and with translators available for other languages.

Those who are not eligible to receive a shot at home will be instead connected with other resources such as the <u>2-1-1 call</u> <u>center</u> to schedule a vaccine appointment.

### Treasurer Goldberg's Veterans' Bonus Division launches online application for Welcome Home Bonus

The Office of the State Treasurer,
Veterans' Bonus Division has launched an
online application for the Massachusetts
Global War on Terrorism (GWOT)
Welcome Home Bonus. Massachusetts
servicemembers and veterans can now
apply online to streamline the application
process and expedite bonus payouts.

Welcome Home wartime bonuses are awarded to servicemembers who lived in Massachusetts for at least six months immediately prior to entering the military and served on or after September 11, 2001. Qualified applicants can receive bonuses for their active service and deployments in support of the Global War on Terrorism. In 2018, \$1.2 million in bonuses were awarded to Massachusetts veterans. ## Scammers target veterans, reserve, and active-duty personnel

A recent article from AARP warned that military veterans and retirees have been increasingly targeted by scammers and fraud. In an FTC report from 2020, it's estimated that military veterans and retirees faced up to \$66 million in losses.

A large portion of these losses are reported to be imposter scams, in which an imposter poses as another individual (government employees, family, romantic interests, etc.) to steal money or sensitive data. The article suggests some advice to make sure you don't fall victim to scams.

- Check your credit statements and credit reports frequently to make sure you are aware of any unauthorized charges or misuse of your personal information.
- Never reply or react to an urgent request for money by buying gift cards, reloadable VISA cards, or sending a money transfer.
- Research ways to spot scams and safeguarding your identity. The Federal Trade Commission offers resources on avoiding scams and provides ways to report them, <u>click</u> <u>here to view</u>.

Always be careful with your personal data when you are interacting with another person, and never give your social security number, financial information, or other personal data to someone else. You can read the full article here:

Some AARP tips to help scamproof your life during a announced that the federal income tax filing due date for individuals for the 2020 tax year will be automatically extended from April 15, 2021, to May 17, 2021.

According to a press release from the IRS, the deadline postponement only applies to individual federal income returns and tax payments otherwise due April 15, 2021. It does not apply to state tax payments or deposits or payments of any other type of federal tax. Click here to read the full press release.

Likewise, the Commonwealth has announced the extension of the 2020 state individual income tax filing and payment due date from April 15, 2021 to match the recently-updated May 17, 2021 deadline for filing federal individual income taxes. For more information, click here.
