Retiree Benefit Verification (BVF) Mailing Coming in June

The 2022 Benefit Verification Forms for retirees of the State Employees' Retirement System will be mailed soon.

There will be no notarization requirement for the 2022 BVF, but your signature on the BVF will still have to be witnessed by someone over the age of eighteen.

Note, the Board processes over 67,000 BVF's and will confirm receipt of an individual BVF starting TBD. In the meantime, members whose BVFs have been received and validated may receive a postcard that acknowledges receipt.

Also, for those who don't receive or return the first BVF, a second BVF will be issued. Be sure to check the Board's website, Facebook, and Twitter pages for the latest updates!

Anyone who received a pension benefit <u>payment prior to 12/31/2021</u> will be included in the 2022 process. If your retirement date was in 2021, but you didn't get paid until 2022, you will not be included in the 2022 BVF process.

Please note, during the verification process, your benefit payments will not be delayed or withheld without prior

House Approves 5% COLA Increase

As part of the FY 2023 Commonwealth Budget process, the Massachusetts House of Representatives included a one-time 5% cost-of-living adjustment ("COLA") for retirees of the State

notification. Board staff will make every effort to contact members who do not return a BVF before withholding benefit payments.

Please keep in mind the following when filling out your form:

- Section 2 MUST be completed (signature required) by the member or the authorized agent (power of attorney (POA), guardian or conservator) acting on behalf of the member.
- If an authorized agent completes the BVF, a full copy of the authorization document must be already on file with the Board or attached to the 2022 BVF. Section 4 (on the back) must also be completed.
- Section 3 must be completed by your third-party witness, who is over the age of eighteen. Their name and signature must be legible. Note, the member and witness signatures MUST have the SAME DATE. (For 2022, the Board does not require the notarization of this form.)
- 4. Please do not mail your completed form to the Board's offices. Instead, please mail your completed form to MSRB, PO Box 167, Randolph, MA 02368-0167.

A similar COLA amendment was filed as part of the Senate's budget deliberations but withdrawn. The proposed COLA changes will be discussed by the House and Senate as part of the Conference Committee process. If eventually approved by both Houses, and approved by the Governor, the COLA would go into effect on July 1, 2022.

In our March <u>Retiree eNews Bulletin</u>, we reported that Treasurer Goldberg announced the creation of a Baby Bonds Task Force. This Task Force will have its first meeting in June and is charged with providing the Treasurer, the Office of Economic Empowerment, and the Economic Empowerment Trust Fund with recommendations for creating a Baby Bond initiative in Massachusetts. This meeting will not be open to the public.

Baby Bonds are significant financial investments made by the government into a collective fund on behalf of newborn children. <u>Studies have shown</u> that Baby Bonds have helped shrink the racial wealth gap.

to May 3, 2023

As a reminder, the Department of Homeland Security ("DHS") has extended the REAL ID enforcement from the previous date of October 1, 2021, to May 3, 2023.

Beginning on May 3, 2023, a standard license will NOT be acceptable to pass through domestic airport security checkpoints. You will need a REAL ID or another acceptable form of identification, such as a valid passport, federal government PIV card or US military ID.
