Meeting Called to Order

- Review Regulation and Proposed Changes
 - 269 CMR 2

The Board reviewed and discussed the updated draft of the proposed regulation changes. Discussion centered around incoming applications for students educated outside of Massachusetts. There is concern that these students do not receive education on Massachusetts regulations and laws. For Massachusetts schools, the Board approves school curricula and can require education in those topics. The Board considered adopting a requirement that licensees who attend out-of-state schools pass a jurisprudence exam; Alexei Levine suggested electronic testing method for schools outside of Massachusetts; no additional cost; Sheila York to flesh out potential wording in the regulation for review at next meeting.

Discussion

- Do Craniosacral Therapy practitioners need to be licensed massage therapists in order to practice Craniosacral Therapy in Massachusetts?
 - The Board discussed that CST is within the scope of an MT in MA, and also performed by other health care professionals. Table for further discussion; referred to Sheila York to draft response for review at next meeting.
- Update on Governor's Article 87 Reorganization Plan and potential impact on MT establishment license exclusion for DPH facilities in 269 6.03(8)(a)(1)
 - Sheila York updated the Board on legislation that changed DPL's name from the Division of Professional Licensure (DPL) to the Division of Occupational Licensure (DOL). The legislation also transferred 13 health-related boards from DOL to DPH, effective at the end of June 2022. The Board discussed how this change could impact the Board of MT. One issue identified was whether facilities licensed by the transferred boards (e.g. CH and PT facilities) would be exempt from the MT establishment license requirement because they may now be considered DPH licensed facilities. Sheila York will seek clarification from the General Counsel at DOL.
