Application Review

• A reinstatement application was submitted by Liangqiong Xiong in <u>December 2023</u>, after her license was revoked, on July 5, 2023, following a determination that Ms. Xiong's 2018 application failed to establish the minimum educational requirements for licensure. The Board reviewed the application and all supporting documents. Ms. Xiong was interviewed, with a Board-provided interpreter, and answered questions regarding her course schedule, the content of the material, and her attendance. Ms. Xiong indicated she attended classes at Jupiter Beauty Academy from 9:00 to 4:30, with lectures on Mondays

and Thursdays and supervised practice Tuesdays, Wednesdays, and Fridays, for 20 weeks. Members inquired as to massage technique studies, health contraindications to massage, state of residence, and where Ms. Xiong intended to practice. Alexei Levine moved to deny the reinstatement application due to the applicant's lack of understanding of lymphatic drainage massage and contraindications and because, given the articulated education schedule, it appeared impossible to meet the Board's education requirements; Seconded by Pallas Hutchison
