Remote meeting procedures – At approximately, 10:02 AM, Paul Andrews confirmed quorum via roll call vote which showed the following members participating via remote means; Paul Andrews, Alexei Levine, Pallas Hutchison, and Kimberlee Schuler; Paul Andrews called the meeting to order.

Ms. Hou was asked if she had reviewed the compliance plan and if she understood the content of the compliance plan and her obligations.
